Performance and Analysis

Business Performance Summary

In Year 2024, the Company reported its total revenue at 1,425.60 million THB comprising of sales and services revenue at 1,422.97 million THB and other revenues at 2.63 million THB. Its cost of sales and expenses were at 1,236.75 million THB or 86.75% of total revenue in 2024. In term of net profit, it was equivalent to 150.16 million THB or 10.53% of total revenue in 2024. In the section of sales revenue from turnkey business showed a decrease comparing to the same period of previous year due to the large projects had been delivered and revenue was recognized in the same period of the previous year and various potential biddings had been deferred. In term of revenue from supply and maintenance, it showed an increase by 29%.


